# Respected Sir,

Dawn to Dusk Fast was organized at IMA Lucknow Branch by Doctors as part of Nation wide Satyagrah of IMA to Press our Demands. Following resolution was passed in General Body Meeting at Lucknow.

As per the decision the Central Working Committee of IMA taken at its recently convened 218<sup>th</sup> meeting held on 23<sup>rd</sup>-24<sup>th</sup> Sept, 2017 at New Delhi, it was decided that all State Branches of IMA shall be observing "Dawn to Dusk Fast" from 6am to 6 pm on October 2, 2017 at a prominent location in their area, in a non-violent structured manner, preferably in front/near a statute of Mahatma Gandhi or his photograph. All State/local branches shall organize:

(1) Special General Body Meetings in accordance their constitutional quorum at the above designated place any time during 2<sup>nd</sup> October, 2017

(2) Shall pass the following resolution and post and email that resolution along with a letter to Hon'ble Prime Minister of India (copy attached) with a copy to Chief Minister of your respective State/Local Administrative Head:

## Resolution

All 1095 (Number of members of your Branch) of Lucknow (Branch name) of U.P. (State name) hereby resolved on 2<sup>nd</sup> October, 2017 that the time has come for the Hon'ble Prime Minister of India to intervene to resolve the following issue faced by the medical professionals in the community effecting the community health on priority:-

- 1. Central Act to tackle violence against medical profession
- 2. De- linking penal provisions against doctors for minor clerical errors in Act like PCPNDT ect.
- 3. Timely amendments in agreed changes in Clinical Establishments Act and PC-PNDT Act.
- 4. Capping of compernsation in cases of medical negligence
- 5. Withdrawal of National Medical Council Bill & EXIT proposal (NEXT)
