Standing Committee of Parliament

Respected Sir.

The NMC bill is referred by parliament for review by the esteem committee. The members of our association have some serious objection in this bill. which are enumerated below. Please consider following and amend the bill as required.

Points to be considered:

- 1. Board members of all the autonomous boards must only be doctors and none other. These elected board members shall be full time members devoted to the council and its activities during their tenure.
- 2. Council members of all boards must be one elected doctor from every state of the country. Elections to be done by regularly and voting by all the doctors in each and every state. Chairperson of all boards and committees shall be any one of these elected doctors only.
- 3. National medical council members who will be the deciding authority must be doctors and not engineers and management personnel. (Since doctors are not involved in fields other than medicine, the same shall be applicable to other fraternities so they don't mingle where they have no purpose). Thus clearly stating that doctors will be the council members. Rest of the workforce shall be officers of the government but shall never be permanent posts which will avoid corruption to a great extent.
- 4. National register must induct only doctors with basic degree as MBBS No other alternative medicine practitioners are allowed in the register at any cost.
- 5. Under no circumstances the fraternity will accept any form of bridge course which may allow members other that MBBS holders to practice medicine and its allied subjects.
- 6. There is no need for a mutual meeting of the councils of homeopathy. ayurveda and medicine. Any outcome from such meetings will be deemed unacceptable by the entire fraternity.
- 7. There is no need of an exit exam. NEET UG, PG and SS is sufficient. Having three exams - University final year exam including practicals. MBBS exit and NEET PG for the same purpose is unnecessary and a complete waste of public resources.

- 8. There shall be no quota system in NEET. Exam to be conducted on the same day for the entire country. Thus proving that whoever deserves may get seats. Counseling shall be single and no conversion or carryover of seats are allowed for the multiple rounds of counseling.
- Like the rest of the world where modern medicine is practiced, foreign medical graduates are only inducted in the system after strict scrutiny by the system and officials. The same shall be applicable to FMG's in India also.
- 10. Any foreign citizen who wishes to practice in India is liable to scrutiny by the council and registration whether temporary or permanent will only be granted after passing a 'licensing' exam.
- 11. SUPPLY AND DEMAND!!! The government needs to for see the supply and demand of medical graduates in the country. Improper planning will only need to more supply than demand in the future and then doctors will be plenty than needed and the fraternity shall become just like engineering in the country today. Also, UG and PG increase of seats are not freebies to government and private institutions alike and should be moderated strictly by the government. Strict measures for supply and demand are to be considered.
- 12. Strict regulations are to be implemented for upgradation of secondary and tertiary level centers to develop them as a centre of excellence instead of just opening new centers. The government needs to improve what exists instead of creating new centers.
- 13. All the statutory bodies under the NMC are public bodies and all their activities shall be available on their respective websites for the general public.

We believe that the esteemed Minister will consider the request of our members.
