SUB: Unrest in the allopathic doctors of UP on short time notice online Registration contrary to Court order by CMOs

Respected Sir,

This is to bring in your kind notice that every qualified doctor in U.P need to register with CMO of his district and get it renewed every year by 30th April because of the order of Hon. Allahabad High Court (Civil Misc Application No 99565 of 2007, in contempt petition No. 820 of2002.) and Hon. Court also instruct that for renewal of registration no documentation is required, only a simple application will suffice and that is what we the qualified doctors are doing every year by submitting the same applicator offline before 30th April. It was started to catch hold the unqualified doctors practicing in the state but we are not aware about how many unqualified doctors being stopped from practicing.

Sir that is how this date bound of 30th April came in existence where we only have to put an application or year registration certificate for renewal without any other documents like Fire NOC, PCB certificate.

This year CMOs had notified through newspapers advertisement for Online Registration just 20 days back with so many columns which were difficult to understand for our maximum doctors. Moreover, majority of doctors are still not aware about this order. As CMO started refusing Renewals and New registrations, our doctors got terrified and approached IMA. Subsequent to this IMA had a meeting with DGHS UP on 17.04.2019 and appraise about the difficulties facing by the doctors of UP on this short notice. He listened and assured for hassle free process which Govt. authorities have mixed without discussing with IMA about the complexity of the process and little time.

One part is yearly registration by the court order before 30th April which does not required any NOC or any other document except the degree to notify the court by Government about the number of qualified doctors practicing in UP Second part is online registration with PCB certificate for BMW management and Fire NOC which is difficult to get in 10-15 days by those who have not taken or applied but could not get that certificate from the respective department reason well known to them only.

We request you on behalf of medical fraternity of U.P. to instruct the Govt. officials to follow the court guideline, So that better medical services continues U.P. for the society without any harassment.

We seek your active and urgent intervention to avoid this unfortunate situation.

High Court Order On Renewal of Registration

Order on

Civil Misc Application No. 99565 of 2007 In Contempt Pention No. 820 of 2002 Rajesh Kumar Srivastava Vs Sri A.P. Verma

Hon, Sunil Ambwani J.

Heard Sri Arvind Srivastava for the applicatant. The intervener application is allowed.

The applicant Dr. Alka Jain is M.D. (Gynecology) 1983 and is enrolled with Medical Council of UP at Lucknow at SI. No. 52605. She is running a 'Maternity Home Medical Clinic' at C-56, Balrampur Nagar, Loni, Ghaziabad. She got her registration in the year 2004 with Chief Medical Officer, Ghazlabad at SI, No. GDB/00996. It appears that she did not apply for renewal on her registration for the year ending 30.5.2006 (the extended date). The Chief Medical Officer, Ghaziabad has asked to furnish the entire details for renewal of the registration in the current year failing which legal steps will be taken back against her.

It is brought to the notice of the court that in many districts renewal of registration of qualified and authorised medical practitioners is causing some administrative difficulties. It is reported that the Chief Medical Officers are requesting the authorised medical practitioners to complete the entire formalities including the submission of

affidavits a fresh as if new registration is required.

The pentioner's application for renewal of registration is allowed with direction to all the Chief Medical Officers in the State that whenever the qualified and registered medical practitioners apply for renewal of their registration they will not be required to undergo the entire formalities unless there is a change in then qualification, place or work, staff or they have added some new facilities in their clinics, nursing homes and hospitals. They will be liable to make a simple application to the Chief Medical Officer of the concerned district along with Xerox copy of the previous years registration and a declaration on the application that they have not added any new medical facility or engaged new personne. Such a declaration will be treated to be sufficient subject to inspections and verifications by the Chief Medical Officer or Medical Officer authorised by him.

Let a copy of this order be sent to the Director General, Medical Health, UP, Lucknow to circulate to all the Chief Medical Officers of the District within a week. He shall make an advertisement for all the medical practitioner to get themselves register with Chief Medical Officers by 30.04.2007 clarifying that in case of renewal of registrations they may make a simple application with the declaration as above, along

with a copy of the previous year's registration.

A copy of this order may be given to Sri J.K. Tiwari learned Standing Counsel for compliance.

Heard Sri Pankaj Srivastava for Indian Medical Association. A supplementary affidavit of Dr. B.B. Agrawal has been filed bringing on record Memorandum of Rules and Bylaws of Indian Medical Association, U.P State Branch as well as the resolution taken in an urgent meeting dated 17-03-2004 authorizing Dr. B.B. Agrawal to file application on behalf of IMA U.P. State Branch before the Court. The affidavit also enclosed forms supplied by the Chief Medical Officer of Shahjahanpur and Agra as well as the application for Performa printed by the Chief Medical Officer, Moradabad.

Sri Pankaj Srivastava submits that a direction issued by this Court may be modified authorizing State Medical Council to be the registering and verifying authority.

Secretary, Medical and Health U.P. the directions were provided. It was made clear that the Chief Medical Officers shall not put any obstacle or create any hindrance. Sri R.B. Pradhan, Learned Standing Counsel has made a statement that in every district one Deputy Chief Medical Officer shall be made incharge of the registrations, and the applications received through the District Branch of Indian Medical Association shall also be entertained. He assured that the office of the Chief Medical Officer shall not cause any obstacle or hindrance and that the individual matters may be brought to the notice of the Principal Secretary of Medical and Health.

List this matter on 13-04-2004.

A copy of this order be made available to the counsel for parties on payment of usual charge by tomorrow. A copy shall be provided to Sri R.B. Pradhan, Standing Counsel for compliance.
